

CITY OF CUERO COUNCIL MEETING AGENDA MARCH 11, 2019 5:15 PM

- 2. Invocation led by James K. Crain, III
- 3. Pledge of Allegiance to the American Flag and the Texas Flag Led by W.T. "Tony" Allen.
- 4. **Public Comments:** Peggy Ledbetter spoke to Council regarding the Veterans Park Project expansion of five feet on both sides of entrance to put a directory stand on the right side and a bench on the left side.

Guy Dolan spoke to Council regarding doing a city wide garage sale in April asking the city to wave the permitting fee and allowing signs in the yards. He will meet with City Manager.

5. Presentation and Recognitions

5.1 Presentation from Crystal Irvin On SNYPD (Spay Neuter Your Pet DeWitt Co.)

A power point presentation was given to inform Council of a new non-profit organization to assist with spay and neuter of dogs and cats in DeWitt County. They will have a consignment shop in the building at 514 French Street to help with funding. They asked if the city would donate their yearly funding to them to distribute. They will meet with the City Manager.

Motion made by Mayor Pro Tem Matthys, seconded by Councilmember Fuqua to approve the first reading of Ordinance No. 2019-07. The motion was approved unanimously.

8.1. Discuss consider and possible action on request from Camal House regarding Utilities.

Director of CAMAL House, Freda Nelson presented to Council how many families they give food and assistance to. She requested relief on the utility service at the business. Motion made by Councilmember Allen, seconded by Mayor Pro Tem Matthys to have City Manager look into it and report back to Council. The motion was approved unanimously.

8.2. Discuss, consider and possible action on report from Linda Henderson On Keep Cuero Beautiful and Keep Texas Beautiful 2018 Litter Survey.

Mrs. Henderson and members of Keep Cuero Beautiful drove around to some of the blighted areas of Cuero and reported to Council the positives and the negatives in District 2. No action was taken.

8.3. Discuss, consider and possible action on amending the previous 50% for the Airport Feasibility Study from \$1000 To \$5000.

Motion made by Councilmember Hedrick, seconded by Councilmember Allen to allow up to \$5000 for the study and to have Ron Price who did the previous study in 2014 to do the study. The motion was approved 5 for and 1 against.

8.4. Discuss, consider and possible action on Downtown Market Days Bi-Law Approval.

Motion made by Councilmember Allen, seconded by Councilmember Johnson to approve the bi-laws. Motion approved unanimously.

Motion made by Councilmember Glover, seconded by Councilmember Fuqua to approve the street closing for the event. The motion was approved unanimously.

David Danish reported that he has received the 5 new mowers for the park and two new mowers for the cemetery. Also has received the new machines to maintain the golf course. He stated they are advertising for a Pool Manager and lifeguards.

Main St. Manager presented work plan to Council which included promoting the bat house, applying for an art grant to do the alley by Standard Printing, and doing a downtown assessment.
